Should the volume you are interested in be out of stock, we will gladly look for it. Our services are completed by offering you previous editions of law titles.

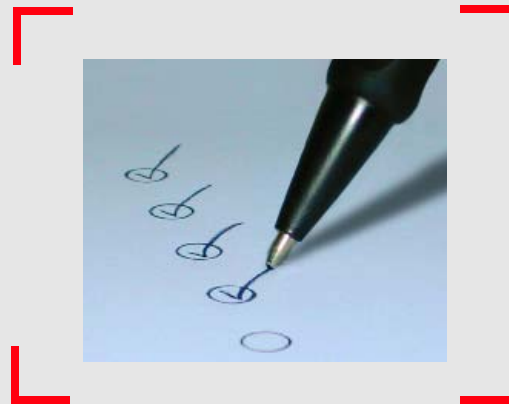
Advantageous purchasing and delivery conditions

The following purchasing and delivery conditions apply to our customers abroad:

Orders

First-time orders can be placed in writing, via e-mail or fax - thereafter we can take your orders by telephone.

Orders marked by you as urgent will be given priority in order to guarantee a quick delivery.



Special conditions relating to subscriptions, loose-leaf works and periodicals

- Unless otherwise required your subscription to loose-leaf works is automatically continued.
- Subscriptions to periodicals remain in force until you cancel them in writing and consequently do not have to be renewed every year.
- The cancellation periods laid down by the publishers apply when cancelling standing orders and subscriptions to periodicals.
- We will invoice you for periodicals once we have been invoiced by the publisher: Hence, if you wish to cancel a subscription to a periodical it should reach us by 30 September of the current year at the latest.

- Invoices for subscriptions and loose-leaf works depend on the publisher, but also on your individual wishes.

There are two options:

- calculation on an issue/release-basis
- calculation as a 1-year-service



Prices

- German language books and periodicals are sent to you at the selling price fixed by the publishers (Ladenpreis).

- We can provide excellent purchasing conditions for foreign books and periodicals because of our longstanding publishing contacts.

Discounts

If you place orders in excess of EUR 15 000 annually we give you a library discount of 5% on German books (this does not apply to periodicals, standing orders, antiquarian titles and foreign books.)

Postal dispatch abroad

- Unless otherwise required the parcels are sent by normal mail.
- The charges that apply are based on the rates of the "Deutsche Post AG" (German Post Office).

- There are no additional handling charges.

Our special service to you:

- We keep your postage costs as low as possible by collecting your goods in our export department for dispatch within a maximum of two weeks.
- Before being dispatched all deliveries are checked again for completeness.



This additional control ensures delivery of the highest quality.

- We make sure that no duty problems arise upon delivery.
- Goods with an approximate value of EUR 30.00 or more are sent by registered mail in order to guarantee a safe delivery.



Payment

Issuing an invoice

Generally the delivery is made on account. In some cases, however, we reserve the right to send out pro-forma invoices.

Terms of payment

in German-speaking countries: 30 days
in the rest of Europe: 60 days
overseas: 90 days
